MESSAGE FROM XIONG UNITED, INC. PRESIDENT BEE KEVIN XIONG

Welcome to our 2019 Xiong United Annual Conference in Sacramento, California. We are all excited to be here today to meet each other, our special guest speakers, our Xiong family doctors, lawyers, professionals, and leaders. Our theme for the conference this year is "The Path to Unite Our Xiong Families for the Best Today and into the Future." By the end of the day, we will learn from each other and get to know each other. I believe that you will find the conference meaningful and educational. It will be a historical event for all of us.



Besides the conference, there will be a banquet and entertainment in the evening where we will present scholarships to our Xiong students and present awards to our leaders, professionals and contributors. It will be filled with fun and a great time to chat with each other from other cities and states. Xiong United was established in 1985 under the name of "Xyooj Koom Txoos" in Ban Vinai refugee camp by Tswj Hwm Xiong, Col. Saidang Xiong, Col. Youa Pao Xiong, Nai Koo Chai Hue Xiong, Ntxoov Neng Xiong, Nengsho Xiong, and Youa Cho Xiong. The goal and objectives were to unit our Xiong families and support each other through leadership, economic, cultural and education. This organization was re-named "Xiong United National. Inc." in 1994 and registered its name in the state of Minnesota.

Xiong United has restructured the organization to better serve our Xiong members locally, nationally, and internationally based on our vision and objectives. Therefore, we have adopted a shorten name "**Xiong United, Inc**." to better represent all Xiong locally, nationally, and internationally. It is a 501(c)3 non-profit organization and is currently registered in the State of Minnesota.

In order for our Xiong families to unit as one throughout the world, we must work together and adopt strategic action plans such as below:

I. Organizational Activities

- 1. Schedule quarterly teleconference with team members around the U.S and beyond to update operational status and solicit feedbacks/input for improvement.
- 2. Schedule annual teleconference with Xiong clan members of all levels to report operational activities and solicit input.
- 3. Schedule monthly board meeting or teleconference with Xiong representative to the 18 Hmong Clan Council to be updated of one's activities on the 18 Hmong Clan Council and recommendation from Xiong United, Inc. for consideration.
- 4. Develop and establish relationship with various agencies, organizations and businesses to train and mentor Xiong professionals and/or potential leaders. Note: Rather than student scholarship, Xiong United will send up to 2 chosen Xiong to attend formal leadership training in one's respective city or state.
- 5. Continue our Census survey every 4 years to ensure we have an accurate count of our Xiong families, doctors, lawyers and professionals.
- 6. Continue asking our Xiong members to donate \$1 per person annually in order to cover the costs of Xiong United activities such as office expenses, scholarship programs, conferences and leadership awards.

II. Education

1. Develop a system or program to identify and collect Xiong students from Junior high school age to University level.

- 2. Develop a softward program to identify and collect data of Xiong professionals and leadership including their respective fields and positions.
- 3. Develop Xiong leadership and professionals Hall of Fame to inspire Xiong youth and commemorate Xiong leaders who made great impact to enrich Xiong clan identity and leadership prestige.
- 4. Develop a data system to solicit the name of Xiong youth and professional who wish to pursue either higher education or want to improve one's leadership skills and abilities.
- 5. Issue certificates of achievement to all Xiong graduates from high school to college.
- 6. Issue certificates of recognition to all Xiong students for academic excellence and completion of certain competitive fields of study.
- 7. Update Xiong United website with inspiring Xiong activities around the world.
- 8. Improve and make Xiong United website a rich information center for Xiong around the world.

III. Cultural Preservation

- 1. Identify and establish a subcommittee of cultural professionals of all faiths to lead and facilitate any needed ceremonial performance especially for those without immediate relatives.
- 2. Establish online help line (Skype or phone) for those who live in small city or need simple cultural advice, etc.
- 3. Establish a list of Xiong Professionals such as Mej Koob, Txiv Xaiv, Txiv Qeej, Txiv Neeb/Niam Neeb and Xwb Fwb (Pastors)
- 4. Establish a historic handbook of our Xiong leaders, doctors, lawyers, and professionals for our children, grandchildren, and the posterities to come.
- 5. Establish a Cultural Proclamation for all Xiong to follow.

IV. Leadership Training and Mentorship Program

- 1. Provide Skype leadership training to Xiong youth and professionals.
- 2. Provide occasional tour to public and private institutions, and learn about leadership knowledge and practices.

3. Establish activities such as youth conference, camping, and sports tournament annually so they could get to know each other and learn from each other.

Dr. Xa Xiong

Dr. Xa Xiong, BA, DC, MD is the son of Captain Yong Ge Xiong and Yer Kue. In 1980, Dr. Xiong immigrated with his family to the United States and resettled in Santa Ana, California. He graduated from Valley High School in 1986 along with a Medical Assisting Certificate and further obtained his Bachelor of Arts degree in Biology and Chemistry from Concordia University. Dr. Xiong conferred his Doctor's degree in Chiropractic Medicine in 1994. He further pursued his medical career in 1997 and conferred his Doctor of Medicine (MD) degree in 2000 from Spartan Health Sciences University, School of Medicine. He completed his Family

Practice Residency at the University of Wisconsin Fox Valley Family Medicine Program.

Dr. Xiong is an American Board Family Medicine Board Certified and practicing as a Family Physician at Ascension Medical Group and serves as the Chair for the Family Medicine Department in Stevens Point, Wisconsin, where he provides medical services to all ages. In 2011, Dr. Xa Xiong received Secretary Eloise Anderson – "JOURNEY OF HOPE AWARD" for outstanding achievement by a refugee during resettlement and integration into American Society. In 2016, Dr. Xiong published "The Impossible Dream: Memoirs of a Refugee Boy" and had inspired thousands of people to pursue their dreams.

The Wisconsin Academy of Family Physician recognized Dr. Xiong as the Family Physician of the Year 2016, who exemplifies the tradition of the Family Physician among 3000 Family Physicians and Medical Residents in the state of Wisconsin. In 2017, Concordia University Irvine selected Dr. Xiong as the Alumnus of the Year 2017 among 20,000 other alumni. On the 21st day of July, 2018, Dr. Xa Xiong was awarded a Citation by the State of Wisconsin from Governor Scott Walker and State Senators Jerry Petrowski and Patrick Testin for his accomplishments and contributed thousands of hours of community services and given over 600 keynote speeches and lectures, inspired and empowered others to pursue higher education, and passionately shared the history of Hmong Americans.

Dr. Xa Xiong is married to Choua Yang, AA, CA, NA. They have five children: Elizabeth Xiong, BA, MD, Einstein Xiong – Pre-Medicine Program: Biology, Emily Xiong, BS, MS in Biological Science, Elena Xiong – Pre-Medicine Program: Biology, and Alexander Xiong – Pre-Medicine Program: Biology.



Dr. May Ying Xiong Ly

May Ying Xiong Ly is currently the interim director at the Women + Girls Research Alliance at the University of North Carolina at Charlotte, North Carolina. She is a social worker by training with extensive experience in the non-profit sector where she was the executive director of two agencies and cofounder of one, all of which helped to advance the awareness and prevention of cancer and mental health issues in Southeast Asian.

She is also a community activist with the Building our Future (BOF) grass-root movement to bring awareness to abusive international marriages and gender-based violence. She is currently focusing her research on intimate partner violence and health disparity in the Hmong community. She has

served as an advisor and liaison to many organizations and shelters working with domestic violence victims.

In 2005, she was the recipient of the prestigious Robert Wood Johnson Community Health Leadership Award for her work in the Hmong community with domestic violence and empowering women and girls. She has a master of social work from California State University at Sacramento and a Ph.D. from the University of California, Davis Betty Irene Moore School of Nursing. She is married with four children and now, a proud grandmother of one little boy.



Minnesota State Representative Tou Xiong

Tou Xiong is an American politician and member of the Minnesota House of Representatives. A member of the Minnesota Democratic–Farmer–Labor Party (DFL), he represents District 53A in the eastern Twin Cities metropolitan area.

Xiong is the second child of eight siblings, born to refugees from Laos, Nhia Kao Xiong and Xe Yang. He graduated from Tartan High School. He attended St. Cloud State University,

graduating with a Bachelor of Arts in economics and later William Mitchell College of Law, graduating with a Juris Doctor.

He previously was an urban planning organizer for the Harrison Neighborhood Association, a legislative clerk for the Minnesota Housing Finance Agency, worked for the Minnesota Legal Aid, the Public Health Law Center, a trustee on the Ramsey County Library board of directors, and a member of the Senate DFL District 53 executive committee. Xiong was elected a member of the Maplewood city council in 2014. Xiong was first elected to the Minnesota House of Representatives in 2018. In addition to his public work at the MN State House, he is the Executive Director of Bancroft Neighborhood Association.

"To me success is achieving one's set goal regardless how small or whatever that goal is. I'm a big believer in setting goals," says Sacramento-based attorney Kou Travis Xiong.

And Kou has lived a life of experiences that align with these words. Kou vividly recalls a challenge he faced after his 8th grade year. Kou scored high enough on a high school placement exam to be placed in advanced courses. However, the high school vice principal intervened and instead enrolled him in English as a Second Language (ESL) courses.

Understanding the high importance of elite colleges placed on the rigor of high school courses and a student's grade in those courses in the admissions process and having a strong desire

to attend the best universities in the world, Kou and his parents confronted the vice principal and demanded to have him enroll in the appropriate honors courses. The vice principal refused and threw every imaginable obstacle at them. But with Kou's persistence, the vice principal conditionally gave in but required Kou's father to sign a waiver releasing the vice principal from any responsibilities should Kou fail in the honors courses. This discriminatory experience motivated Kou and it helped to solidify his belief that success requires not only having goals but also strong conviction.

Challenged by the rigor of the advanced college preparatory courses, inspired, and motivated, in part by the vice principal incident, Kou went on to graduate near the top of his high school class and earned essentially a full ride to one of the most prestigious colleges in the world, the University of California at Berkeley, where he earned a Bachelor of Arts degree in Political Science and a minor in Asian American Studies with an emphasis in law.

Committed to his passion for the law, Kou went on to attend law school at the University of Idaho College of Law. While in law school, Kou handled misdemeanor trials and appeals, as well as family law cases, through the law school's clinical programs.

Following that, he worked as a hearing representative for the California Correctional Peace Officers Association, then as a Staff Attorney for the State Compensation Insurance Fund, and later entered the private sector at a large, state-wide law firm, called Grancell, Lebovitz, et al, defending big corporate business and insurance giants, such as AIG, American Airlines and Wells Fargo Bank.

After several years in private practice, Kou returned to work for the State of California as a Senior Attorney representing the State in complex class action litigations involving civil rights, constitutional laws, and the Americans with Disabilities Act.

In May of 2012, Kou opened his own law office, practicing in various areas of law, including criminal law, family law, workers compensation, immigration law, personal injury law, among others. He is married to Chao Lor, who is also an attorney and works for the California Department of Insurance as a senior attorney. Kou and his wife are proud parents of a daughter, who is an accomplished collegiate golfer and a future attorney.

In addition to his full-time jobs, Kou set aside time to be active in the community. Among his many community activities, he served as the General Counsel of the Hmong American Ad Hoc Committee of Sacramento, which organized and rallied against the arrests of the late General Vang Pao and eleven other Hmong leaders. For 7 years, Kou was the President of the Board of Directors of the Urban Charter Schools Collective (UCSC), a not-for-profit organization that manages and operates the first Hmong independent public charter school, Yav Pem Suab Academy, which he helped to establish, in Sacramento, California. Currently, Kou serves as the special counsel to the Xiong United National, Inc.

In the future, Kou would like to be a part of the establishment of a successful Hmong Chamber of Commerce or a professional Hmong business network not only in California but throughout the world.

Discussing what he envisions for the betterment of the Hmong community, he states that "we must move away from the politics of the older generations and forge a future based on solid foundations of respect, trust, professionalism, and integrity."

With the increasing number of educated Hmong Americans, Kou strongly believes "the future of the Hmong, not only in America but all over the world, will be brighter and more exciting." Kou says that one of his life's goals now, which he promises, is "to play a big role in shaping that future."

Kou now resides in Sacramento, California.
